

# Galaxy Network Ltd. wRKFL Certificates

## Terms and Conditions

### Definitions

**Distributed Ledger Technologies** – relates to an emerging technology whereby a collection of distributed cooperating nodes is arranged to execute (a) protocol(s) to process transactions in accordance with a security scheme enabled via asymmetric cryptography.

**Blockchain** – is a distributed history of all transactions processed in accordance with a prescribed protocol to effect an accounting of allocated units.

**Ethereum** – an advanced distributed ledger technology protocol supporting Turing complete functionality.

**ERC-20** – a scheme under the Ethereum protocol whereby a prescribed number of units may be 'minted' and thereafter be allocated to any qualified address and further transferred at will under control of any person in possession of a specified private key.

**wRKFL** – is a unit of ERC-20 contract instantiated at block #17048765, on April 14, 2023, with transaction identified via hash:

0xb0a7bc847065dd3cdc203eebc2e72316999bdbf8ead7b269d59865376b183331

**Certificate** – A 'certificate' is a certified proof of donation. A certificate issued by Galaxy Network is embodied as some numeric quantity of total ERC-20 units held on a single blockchain address.

**Donation** – a 'donation' is a irrevocable gift made via transmission of cryptocurrency transaction to any address controlled by Galaxy Network, and is not a purchase of anything.

**Sales** – a 'sale' is an exchange of something value for in kind value. Galaxy Network does not and cannot engage in any manner in any kind of token sale transactions, or sale transactions of any type.

### Terms

- 1) By conveying ETH to Galaxy Network, you are making an irrevocable donation for the sole purpose of promoting network use and growth.
- 2) You acknowledge that return receipt of ERC-20 wRKFL is a certificate of donation to memorialize and register the donation having been duly received and made.
- 3) You understand the entirety of the ETH donated by you is consumed to purchase retail products to be given away via a lottery mechanism for network promotional purposes.
- 4) All donors agree, represent and warrant, prior to making a donation, that they are not persons subject to US jurisdiction, law, control, governance or in any way otherwise related to the United States or any of its territories. US persons are **strictly prohibited** from participation in any Galaxy Network related programs. US persons are ineligible to participate in any aspect of Galaxy Network activities.

- 5) By transmitting ETH to Galaxy Network, you agree, prior to making any donation, to submit to the exclusive legal jurisdiction of Gibraltar who shall have sole legal authority to adjudicate any matter related to activities taken up by Galaxy Networks.
- 6) You further acknowledge that Galaxy Network does not conduct any manner of transaction characterized as a sale transaction regarding any product, service, commodity, security, or any other thing.
- 7) Any wRKFL transmitted by Galaxy Network is merely a certificate of donation that reflects the time, quantity and pseudo-identity of a donor.
- 8) wRKFL cannot be returned, exchanged, nor redeemed by Galaxy Network for anything of value by Galaxy Network and donations are strictly unidirectional without possibility of return under any circumstance.
